

# Licensing Disclosure – Master of Science Programs

New York State prides itself in the high quality of its licensed and certified professionals. For the protection of its citizens, each license and certificate has requirements that individuals must meet in order to be licensed or certified in New York State. SUNY's academic programs leading to licensure or certification are carefully designed to meet and exceed these State requirements. This is a role SUNY plays in protecting the public. Other states frequently have their own requirements, so if your goal is to practice in another state, this disclosure will help you check to see what that state requires.

Per U.S. Federal Regulations, §668.43 (2019 Rule), and in compliance with the State Authorization Reciprocity Agreements (SARA) Manual version 19.2, Stony Brook University School of Nursing provides the following disclosure related to the educational requirements for professional licensure and certification.<sup>1</sup>

This Disclosure is strictly limited to the Stony Brook University School of Nursing's determination of whether its educational program, Master of Science - with concentrations in Adult Gerontology Primary Care Nurse Practitioner, Family Nurse Practitioner, Women's Health Nurse Practitioner, Neonatal Nurse Practitioner, Pediatric Primary Care Nurse Practitioner, Psychiatric Mental Health Nurse Practitioner and Nurse Midwifery - that if successfully completed, would be sufficient to meet the educational licensure or certification requirements in a State for advance practice nursing.<sup>2</sup> The Stony Brook University School of Nursing cannot provide verification of an individual's ability to meet licensure or certification requirements unrelated to its educational programming. Such individual determinations are made by state licensing boards, and are fact-specific determinations.

This disclosure does **not** provide any guarantee that any particular state licensure or certification entity will approve or deny your application. Furthermore, this disclosure does **not** account for changes in state law or regulation that may affect your application for licensure and occur after this disclosure has been made. **Enrolled students and prospective students are strongly encouraged to contact their State's licensure entity using the links provided to review all licensure and certification requirements imposed by their state(s) of choice.**

<sup>2</sup> This determination is based on the educational and curricular requirements of each state for licensure (i.e., excluding any special, temporary licensure that may be granted) and does **not** imply that other requirements for licensure do not exist or have been determined to have been met by this program or that any necessary approvals for clinical placements have been secured at the time of enrollment. An unencumbered RN license in the state of intended practice is a requirement of entry and continuation in the program.
